**FEE STRUCTURE FOR REGULAR CANDIDATES:**

The prescribed Examination fee is **Rs.1180/- + Rs. 60/-** [Provisional Certificate] + Memorandum of Marks **Rs.60/- + Rs.300/-** [Examination Processing fee] = **Total fee is Rs.1600/-**

**FEE STRUCTURE FOR BACKLOG AND IMPROVEMENT CANDIDATES:**

The prescribed Examination fee is **Rs.1180 + Memorandum of Marks Rs. 60/-** = **Total fee is Rs.1240/.**

*2014-2015 batch candidates have to pay with a fine of Rs 1000 /- per paper along with Examination fee.*

**GENERAL CONDITIONS TO THE STUDENTS:**

1. Candidates are advised to enclose the Xerox copy of Degree Certificate duly attested by the Principal, concerned college to their Examination application forms along with **Migration certificate [original] & Rs.250/- towards Migration fee** has to be paid by other than OU candidates.

**GENERAL CONDITIONS TO THE PRINCIPALS:**

- 1 The Principal is requested to submit the fees for received application forms only. Fee paid for un-received application forms are not refundable. Individual Demand Drafts submitted by the students will not be accepted.
- 2 As a part of the Core Banking System, all the students are hereby instructed to deposit examination fee into their respective college Principal's accounts only (students are advised not to obtain the DD in favour of the "**Controller of Examinations**", OU.
- 3 The Examination Application forms (EAF) is to be submitted online through College Login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch, duly signed by the student and the Principal concerned along with photocopy of qualifying examination. Xerox copies of Examination Application Forms & Photographs will not be considered.

- 4 The College Principal is requested to deposit (**credit**) the consolidated examination fee amount into "**Registrar, Osmania University, Examination Fee Fund Account No:52198262033**" in any branch of State Bank of Hyderabad and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms.
- 5 The Principal is requested to verify and forward all the **ONLINE APPLICATION FORMS** immediately along with the **Nominal roll , Fee Particulars and subject wise data in duplicate.**
